WAIVER I hereby agree and consent to the following conditions of participation in the 2010 Father & Son Tournament held by Carolina Mens Baseball League, Inc. (the “League” or “CMBL”) :

1. I warrant and represent that the information provided herein is true and accurate. Unless I am registering as part of a specific team, I consent to assignment to a team by CMBL based on its sole determination.
2. I acknowledge that I have read and am familiar with the Code of Conduct and Rules established by the CMBL and that I will comply with and obey them at all times while I am participating in the 2010 Father & Son Tournament. Specifically, I understand that unsportsmanlike behavior, malicious, flagrant or unsafe conduct, fighting or use of abusive or offensive language will not be tolerated by the CMBL and engaging in such conduct may subject me to suspension, fine or expulsion and forfeiture of all fees paid.
3. I certify that I am physically and medically capable of participating in 2010 Father & Son Tournament and specifically assume all risks attendant to playing the game of baseball and associated activities. I further agree to comport myself in a manner that will ensure the safety of myself and fellow participants and others at all times during the 2010 Father & Son Tournament. I knowingly waive any and all claims, suits, actions of any nature whatsoever against the League or any entity, individuals, officers, directors, affiliates providing facilities or services to the League or its participants and agree to hold the League harmless for any and all claims against it or its providers or vendors. I fully realize that any costs incurred as a result of my participation in the 2010 Father & Son Tournament are my sole responsibility. By signing this agreement, I release the League and its providers and vendors from any liabilities, expenses or costs relating to League activities.
